Mr. Steve Lucado delivered the financial report. The club is very healthy \$180,000 with about 22k annual award dinner outstanding costs we are over 150k as a club balance. P&L current net profit of about 21k. Bottom line is club is burning through cash so without the significant contributions from MH we would finish the year in the red.

9. Schools Committee Report (Palmer) 12:55-13:00

Julie gave report. Congrats to Alex Bernat for admission to H. Unable to host admits party sow e held a virtual event which was reasonably well attended. 15 zoom sessions were held by current students for admitted students. 59 commits for 2024, 1 deferred and expect a few more admits from wait list. Yield is about 83 percent. May hear some news from Cambridge later this week, H will go back to school this fall but we are waiting for how they go back. Plan should be available July 1. Number of admitted students and number of accept were records for HCC.
